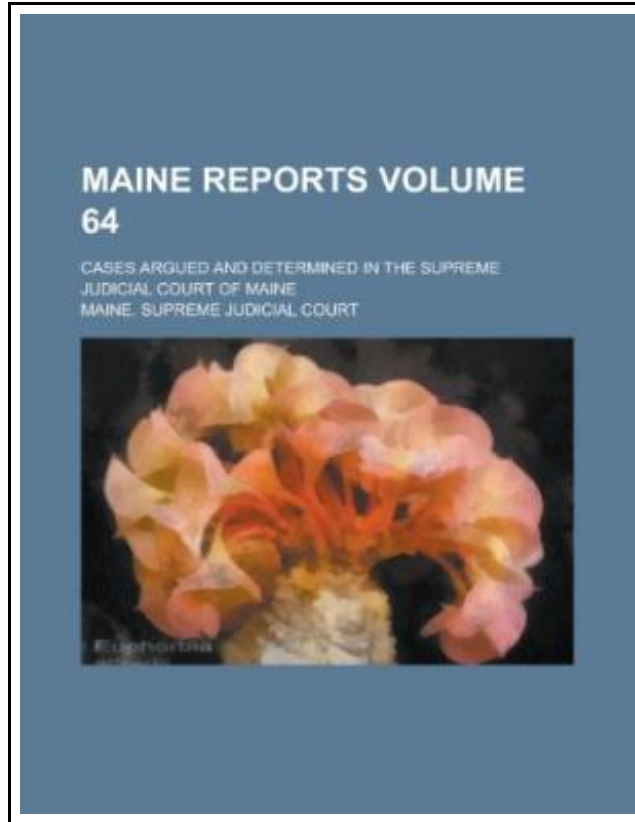

The commissioners were justified in proceeding when, and as they did after notice to the town, upon petition of those interested, to cause the work to be done by an agent not one of themselves. That agent made his written contract for the work and filed a copy of it in the clerks office and the commissioners certified to the assessors of Waterville the time when the contract was to be completed and the amount to be paid therefor.
